FINANCIAL RESULTS OF THE COMPANY**

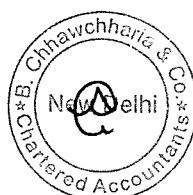
TO THE BOARD OF THE DIRECTORS OF IKAT EXPORTS PRIVATE LIMITED

1. 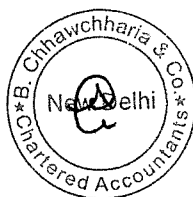
